17	168	6.3	Delete points 7.0 to 8.4 and all in the blue box except the last line. The Carnac Road ahead has been closed due to a small bridge being considered unsafe. Turn right here into Britannia Creek Road. 0.4 keep right. 0.8 Turn left. 0.7 Turn left into Mt Paris Dam Road. 1.7 Mt Paris Dam is 100m along the track to the left. 21	155	2.5	A new walking track has been constructed to the stampers now accessed from the from the Anchor Mine access road (point 2.4).	A/C Jan 2018
22	154	Top of page	Sun Flats Road has been subject to considerable erosion and is now more difficult. Vehicles should be accompanied by others and recovery equipment carried. A culvert has collapsed on the left side of the track and there is a danger that a vehicle wheel may drop into the hole.	A/C Jan 2018
23	179	7.2	Not far past this junction the track crosses a creek. The log bridge is unsafe and the ford adjacent has steep approach and departure slopes that may require vehicles to be winched. The track to the north has eroded and would be rated hard after rain.	A/C Jan 2018
